A Resolution in Support of Removing Barriers to Reproductive Freedom

A Resolution related to removing barriers to reproductive freedom offered by the New Hampshire Democratic Party, for consideration by the New Hampshire Democratic Party Convention on Saturday, May 9, 2020.

WHEREAS, We believe reproductive rights are human rights; and

WHEREAS, We believe unequivocally, like the majority of Americans, that every person should have access to quality reproductive health care services, including safe and legal abortion — regardless of where they live, how much money they make, or how they are insured; and

WHEREAS, We must oppose discrimination and barriers that inhibit meaningful access to reproductive health care services, including those based on gender, sexuality, race, income, disability, and other factors; and

WHEREAS, In our state and across the nation access to abortion care is under attack in legislatures and the courts; and

WHEREAS, The Hyde Amendment allows politicians to interfere in the private health decisions of people and unequally and disproportionately affects low- income people, people of color, young people, and immigrants; and



WHEREAS, The Supreme Court has repeatedly affirmed the constitutional right to choose abortion, making clear the legal imperative that government has no place getting in between people and their doctors; and

WHEREAS, New Hampshire has a long history of majority support for reproductive rights;

THEREFORE BE IT RESOLVED, that the 2020 New Hampshire Democratic State Convention calls for the repeal of the Hyde Amendment as a necessary step forward to ensuring everyone can equally access their constitutionally-protected right to abortion care.

A Resolution to Endorse Medicare for All by the New Hampshire Democratic Party, for consideration by the Virtual New Hampshire Convention on Saturday, May 9, 2020.

WHEREAS, we believe as Democrats we need to move toward universal health care by expanding participation in Medicare, a single-payer system, that is affordable not just accessible; that as a party we should unify by working toward a consensus policy.

WHEREAS, we believe a sustainable, cost-effective approach is to have one risk pool. The current system has two: private insurance profits from insuring the pool of mainly healthy, working adults, and the government insures the high risk: people with disabilities, people experiencing poverty, and all people the age of 64.

WHEREAS, we believe comprehensive, quality health insurance should not be dependent upon having a well-paying job with benefits. The COVID-19 Pandemic lays bare the travesty of millions of people losing their jobs and consequently their insurance.

WHEREAS, it will require Democrats to sponsor legislation that expands upon the Affordable Care Act with a Public Option opening Medicare to everyone.

WHEREAS, we believe Medicare premiums must be prorated by income, free for those who would now qualify for Medicaid, and remove the income cap.

WHEREAS, we must amend Title XVIII (Medicare) of the Social Security Act to require



Centers for Medicare & Medicaid Services (CMS) to negotiate with pharmaceutical companies for lower drug prices; make Medicare more comprehensive; empower the CMS to negotiate for sustainable, consistent, and reasonable reimbursement rates for medical providers and hospitals across the nation.

THEREFORE BE IT RESOLVED, that the 2020 New Hampshire Democratic State Convention supports a transition to Medicare for All.
